Appendix A: Pitbull Tactical USA TERMS AND CONDITIONS OF SALE

Thank you for partnering with Pitbull Tactical USA ("Pitbull Tactical") as an authorized dealer. These Dealer Terms and Conditions ("Agreement") outline the terms and conditions governing the relationship between Pitbull Tactical and the authorized dealer ("Dealer"). By entering into this Agreement, both parties agree to abide by the following terms:

1. PRODUCT PRICING AND MSRP POLICY

- 1.1 MSRP (Manufacturer's Suggested Retail Price): Dealers are required to adhere to an MSRP of \$25.00 per unit for all Pitbull Tactical products. Dealers are prohibited from advertising prices below this specified MSRP.
- 1.2 MAP (Minimum Advertised Price): Dealers are required to adhere to a MAP of \$19.99 per unit for all Pitbull Tactical products. Dealers are prohibited from advertising prices below this specified MAP.
- 1.3 Pricing Flexibility: Dealers are permitted to set their own retail prices, but the advertised price must not be below the MSRP and MAP.
- 1.4 Discounts and Promotions: Any discounts, promotions, or special pricing must be pre-approved by Pitbull Tactical in writing.

2. SALES CHANNEL RESTRICTIONS

- 2.1 Exclusion from Third-Party Platforms: Dealers are strictly prohibited from selling Pitbull Tactical products on third-party platforms, including but not limited to Amazon, eBay, Walmart, and similar online marketplaces.
